## **TERMS**

I, \_\_\_\_\_\_, agree to be bound by the following terms: All booked sessions are pre-paid or require a valid credit card number and require 24-hours notice to reschedule, otherwise client forfeits the booked session's full fee. Initial consultation fee is the same for all services. Setting up an official COMMISSION (web design, painting/installation, and/or space design) requires a minimum deposit of half the estimated full investment (TBD) for final piece in order to begin. Remaining balance is due upon pick-up. Buyer will arrange transport and installation of final piece, which includes clearing his/her existing space of outdated clutter. Buyer releases AIONIOSZOE from any and all damages, losses, and/or acts of God that may occur upon or after pick-up of final piece. Buyer understands that space design encompass an investment in mainly a re-design and agrees to execute it with minimal supervision. All purchased BODYWORK/ LIFE COACHING sessions expire within 1 week (1 session/ Initial Consultation), 4 weeks (Package of 7), 6-7 weeks (Package of 12 and Package of 15 Sessions, respectively). The INTRO-PACK of 5 MINI BODYWORK only sessions expire in 2-months from date of purchase. Unlimited Monthly MINIs are 25-minutes each, require a 6-month commitment for 1,200 USD per month, and must be scheduled ahead, with no appointment changes. Mentorship requires a minimum of a 3-month commitment for 1,000 USD per month. Completion of all 4 Levels (12 months total) is required to be considered for authorization to coach AIONIOSZOE's method. Clients mentored by AIONIOSZOE will take notes throughout progression and present a required, final manual at conclusion of mentorship. Business partnership is not an option. Onsite BODYWORK/ LIFE COACHING sessions NOT at the studio space provided by AIONIOSZOE requires additional fee for travel (TBD based on location). In this case, AIONIOSZOE has full rights and freedom to speak about matters pertaining to creativity. Client breaks it; clients buy it (Equipment, props, property). Hire for workshops is available booked 3-months in advance

(Fee TBD). No refunds. AIONIOSZOE reserves the right to refuse services for any reason, which is the only case a refund, minus processing fees, will be given. No checks. Any change in fees at aionioszoe.com do not apply to clients' existing bank balance with AIONIOSZOE. All BODYWORK/ LIFE COACHING clients wish to participate in AIONIOSZOE's program and understand the potential risks, including, but not limited to, heart attack, stroke, bodily injuries, and death. Clients assume all risks which could occur by his/her participation in this program and fully release AIONIOSZOE from any and all liability with respect to injury, loss, death, or damage to clients' person or property in connection with his/her participation in this program.
